**WRIT OF SEIZURE AND SALE**

TO: HONORABLE CRAIG WEBRE, Sheriff of the Parish of LAFOURCHE, State of Louisiana.

WE COMMAND YOU that by seizure and sale of the property of NATASHA ANN SHUMAKER, DEVIN J.
